Those who are enlisted in « Category 1- Computer Hardware & Computer Accessories » and « Category 2- Computer Consumables» of ICT Operation Department, Bangladesh Krishi Bank, Head Office, Dhaka are eligible to participate in the tender. The participating company must be a licensed (From the proper authority of Bangladesh Government) Supplier.
- 4. The tender shall be completed and signed by an authorised representative of the tenderer.
- 5. Payments made against any Purchase Order arising from this Tender will only be made in Bangladesh Taka. The Unit Rate(s) offered by the Supplier, if accepted, shall remain fixed for the duration of the Purchase Order.
- 6. Last date and time for collection of tender document from ICT Operation Department is on or before 25-06-2024 till 3.00 PM. Your tender must be delivered to the office of the undersigned on or before 26-06-2024 at 3.00 p.m. Any tender received later than the scheduled time will be rejected and returned unopened. The envelope containing the tender must be clearly marked Tender (LTM) for Lot-1 Supply of Computer Consumables for Bangladesh Krishi Bank, Lot-2 Supply of Computer Accessories for Bangladesh Krishi Bank, Lot-3 Supply of 2(two) Document Scanners for Bangladesh Krishi Bank, and DO NOT OPEN before 26-06-2024 at 03.30 p.m.
- 7. Those who are enlisted in Category 1- Computer Hardware & Computer Accessories are eligible to participate in Lot-2 & 3 and those who are enlisted in Category 2- Computer Consumables are eligible to participate in Lot-1.
- 8. All tenders must be valid for a period of 60 (sixty) days from the closing date of the Tender (LTM).
- 9. In the case of any arithmetical discrepancy between the Unit Rate and the Total Amount quoted, then the Unit Rate shall prevail both for the evaluation of tenders and for the subsequent Purchase Order.
- 10. Depending on the final requirement, the quantities shown may be increased or decreased by 15% (fifteen Percent) and this shall be reflected in the Purchase Order.
- 11. The Purchaser is not bound to accept the lowest tender and reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
